## ORDER

The above appeal filed on 18-02-2014 has come up for final hearing before the Vidyut Ombudsman on 24-04-2014 at Hyderabad. The grievance of the appellant is that, in spite of there being a final order from the CGRF, the

respondents have not implemented the CGRF order and have been forcing the appellant to pay bills in excess. The respondent AAO and AAE have appeared along with the appellant for hearings. At the time of final hearing on 24-04-2014, the respondent officers have filed ledger details showing that the compensation of Rs. 5,200/- that was awarded by CGRF has been credited to the appellant's account on 17-04-2014. They have also filed a statement showing revision of bills for the period July 2013 to December 2013 duly reversing the excess of Rs.2,229.26 in favour of consumer. The consumer who was present at the time of hearing also confirmed that, with this the respondent officers have shown compliance to the orders of the CGRF.

- 2. Having considered the appeal, the written and oral submissions made by the respondents, and the appellant, the appeal is disposed of as solved.
