ORDER

The above representation was filed on 03-11-2015, informing that their power supply was disconnected for non-payment of an abnormal bill for the month of May, 2015 and that in spite of their approaching the CGRF on 10-08-2015, the CGRF has neither disposed of the complaint nor given them any relief restoring power supply. Therefore, an interim order was passed on 04-11-2015 ordering the respondents to file their written submissions before the CGRF, among other things, to facilitate an early disposal of the matter by the CGRF. During the hearings conducted at Tirupati on

22-12-2015, the respondents had filed a copy of the order of the CGRF disposing the complaint before it. Thus, the raison d'être for the pendency of the representation before this authority no longer exists and hence the matter is closed.
