- Having been aggrieved by the orders dated 26.11.2025 in C.G.No.876/2025 rendered by the CGRF, APEPDCL, Visakhapatnam, the complainant therein filed this present representation under clause No.18 r/w 19.2 of Regulation No.3 of 2016 seeking "for disconnection of the above illegal power connections till disposal of the suit" as prayed for in the Annexure II under the head "Nature of relief from the Vidyut Ombudsman dated 20.12.2025".
- Heard at the stage of registration of the representation.

3. For the following reasons, the representation is rejected as per regulation 19.3 of Regulation 3/2016:

- (1) Person who filed the representation is not the person who is actually aggrieved. There is no provision in the regulations to entertain such a representation.
- (2) The dispute between Korada Vijayalakshmi and Konchada Jaya Lakshmi and 2 others is covered by civil suit O.S.No.83/2018 in Srikakulam Court.
- (3) All orders relating to the property covered by the suit schedule shall be passed in the suit only.
- (4) When dispute is pending before Civil Court, parallel proceedings cannot be held.
